Dear Applicant,

The North Central District Allied Connections (NCDAC) is seeking proposals from interested and qualified agencies to provide care, support and housing services for those infected with and affected by HIV in the 12-county region of North Central Pennsylvania. Agencies that have the ability and capacity to provide services to persons living with HIV within Bradford, Centre, Clinton, Columbia, Lycoming, Montour, Northumberland, Potter, Snyder, Sullivan, Tioga, and Union counties are encouraged to apply.

Each year, NCDAC receives funding from the Pennsylvania Department of Health. The funding comes from three grant programs: State 656 funds, Ryan White Related Rebates and The Housing Opportunities for Person with AIDS (HOPWA) Program. State 656 funds will not be a part of this proposal process.

The Subgrant(s) awarded will be funded on a fee for service basis and will be for a 12-month (1-year) period from July 1, 2022 through June 30, 2023 with an option of renewal. The number of awards will be based on the quality of the individual proposals received as determined by the Independent Procurement Panel.
